The finding is listed below for each individual alleged violation of the Wyoming Child Care Licensing Rules:

1. Finding: Non-Compliant

Regulation: Chapter 4. General Requirements
Section 10. Records.

(d) Individual child's records shall be in place before a child is left in care and shall include:

(i) The child's full name, birth date, current address and date of enrollment;

Explanation of Findings: Child records are incomplete.

Action Required: Ensure child records are on site with all current required documentation. Children may not be left in care without a completed record on site.

Administrative hearing procedures are included in the Wyoming Department of Family Services Contested Case Hearing Rules, Chapter 2, Substitute Care and Child Care Licensing and based on the above statute. If you need a copy of the Rules, or assistance in requesting an Administrative hearing, you may contact the Department of Family Services Field Office in the county where you live.
